

**August 31,2002, Brownsville, Texas**

Psychotronic bombardment (or related technology) causes sleep deprivation in T from August 28, 2002 through August 30, 2002 (in increasing intensity) and on the 31st, T is exhausted both physically and intellectually. Then, on the morning of the 31st, the fbi assassins observing T en route to computer begin by remote control locking and unlocking the car doors to T's car. T suspected psychotronics being used against him previously, but now T is certain that he is the object of such mind games and that this is relatively new and consistent with the terrorist's message earlier this week about the "new game" that the Handler 'thinks' T will enjoy.

Both GF in Italy and JG in the United States confirm that the "new game" message is possibly the work of thugs. GF writes, " It is certain possible that some of the 'persons' who think to simply make their task or who are so dull and enslaved to commit actions like those against you and others, can also have got this 'silly' message like something considerable for their 'game'..."

As I just reported the assassins now increase their attacks on me, using high tech sleep deprivation methodology. I know of no effective defense to this escalation of assaults. However, as I promised I will charge until I drop dead. As Clint Eastwood reminded us in outlaw Josey Wales, " Men like us don't fear death; it's living that is difficult sometimes".

**September 6, 2002**

T notices that he is now apparently under psychotronic assaults every night with the following indicia: For about the past week T is unusually tired and sleepy at around 9:00 PM, but a minute or two after he attempts to sleep, T notices that he is not sleepy, but that he is tired. T hears nightly (all night) slight high pitch ring-type noise; through the night T estimates that he sleeps two - three hours; this is measured by T in increments of thirty (thirty) minutes to one hour as T looks at his watch throughout the night. The next morning T awakens at about 8:30 AM with headache which continues on and off on some days. The sleeping pattern is completely different from T's usual pattern and T thinks that high tech sleep deprivation activity is now employed intensely every night.

**September 8,2002:**

Home and car invasions (and tamperings therein) continue when fbi thugs lower the back window (again) of T's vehicle during a rain storm (again).

Other psychotronic operations against T continue. However, T sees a failing and pathetic mind-set in the thugs who continue to repeat the same harassment and terrorist techniques that have not been successful in silencing T for four (4) years. The "new game " that the fbi thug promised T ( through an e-mail) in Brownsville, Texas, is not so 'new'. So, even the chief fbi hoodlum can't get it right; that is to say that the chief just can't quite find the effective demonic tool to silence T. The fbi assassins are apparently told (by professionals) that eventually these terror-tactics will wear down the target and cause a complete nervous breakdown, especially as T is isolated, marginalized, medically injured ( in his late fifties) and financially ruined.

All thugs, including the handlers in the fbi and the cia, have no concept of their own illness and depravity and therefore cannot expand their thinking beyond the immediate tasks associated with killing the target. Ultimately, the target is dead, but so are the assassins;

what remains is another chapter in the history of torture, homicide and man's cruelty to his fellow man. The target does his job by making clear to the world through his reports that humanity is still on the decline.

**September 11, 2002: Brownsville, Texas, 78522**

**T reports theft/tampering with time sensitive mail to postal authorities listed below on August 30, 2002: Richard Hernandez (manager), Ben Mendoza (sup**

**e**

**ervisor) and Robert Pantoja (Inspector); none of these authorities made inquiry/investigation. On September 10, post office employees at Brownsville, Texas 78522, admitted that an anonymous individual placed an incorrect code on T's mail box (on or about August 30,2002) indicating "Forward Mail". All of T's mail was then withheld from T's box until September 10,2002, even though the top authorities at the post office were aware of T's reports of mail tampering as of August 30, 2002. T sends letters (seen below) to Postal Board of Governors on August 30, 2002 and on September 10, 2002. T also notifies Pantoja on August 30,2002 that T was assaulted in the post office on August 30, 2002, at the same time the mail was being tampered with, but Pantoja ignored T's report. Then, on September 11, 2002, as T confirms the above facts to Hernandez, the fbi thugs enter T's car and tamper with the settings.**

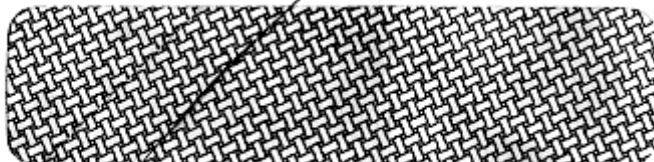
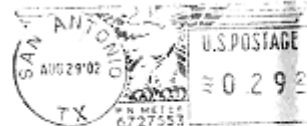

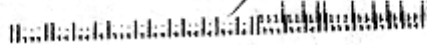

Dear Sir,

This letter confirms my conversation yesterday (August 29,2002) with Postal Inspector Robert Pantoja (telephonic contact), Postal Supervisor Ben Mendoza (in person), and Postal Manager Richard Hernandez (in person) at the United States Post Office at downtown Brownsville, Texas, zip 78522, during which Sosbee reported the recent and repeated theft and tampering of his mail from the above referenced box number.

The tampering occurs as follows: the fbi seizes the mail, takes out some or all of the contents and then surreptitiously notifies Sosbee that the mail is being tampered with. Sosbee confirmed on August 29,2002 , that one specific and identifiable piece of mail was so tampered with. It was a letter from the USAA Federal Savings Bank stating that a form is enclosed; no form was enclosed. Sosbee confirmed with USAA Federal Savings Bank employee Kathy Price that the item was in fact enclosed when it left USAA offices. This kind of mail theft/tampering has been occurring regularly and repeatedly for about three weeks. I have to fax all forms now , due to the theft.


Presently I am the object of fbi/cia campaign designed to silence/neutralize or to kill me.

All of the postal executives mentioned above could not help. In fact , after I presented this information to Inspector Robert Pantoja , he made the following statement, " Let us know if we can assist in some way".

Well, I think that based on my prior dealings with the postal hierarchy and considering the reluctance/inability of the postal staff to look into my reports, that in fact perhaps no one can be of assistance when the fbi and the CIA are busy trying to kill their targets. The last time I brought this type of activity to your attention, Mr. Dyhrkopp, no action was taken.

This letter is a request that you order an investigation into my reports. The United States cannot survive if the authorities are afraid of the fbi and the cia . These two rogue and murderous agencies have ruined our once great country.


Dear Mr. Dyhrkopp ,

Specifically, the Post Office delivered the tampered mail to me today and stated that all of the mail (about 6 items) were held back because an unknown individual changed the description on my mail box causing all of my mail to be held, not delivered, and marked to be forwarded.

This all occurred during the same time that I asked your Postal Employees to investigate tampering and theft of my mail.

In other words all of your high level staff ,including an inspector, are aware of the fbi theft/tampering of my mail and all assisted the fbi in the crimes.

Dyhrkopp (and his Inspection Division) are now corrupted by the fbi and are therefore complicitous in the postal crimes which the fbi commits regularly and at will. GERAL SOSBEE

From Brownsville, Texas .September 18, 2002

During the past four days the fbi thugs stop tamperings and messagings, but on the afternoon of September 17, 2002, fbi terrorists use remote control to lock and unlock T's car doors as T exits the car; T is not sure of the meaning of the renewal of thug activity until the evening. Psychotronic bombardment commences intensely on the evening of September 17, 2002, causing sleep deprivation all night (as fbi terrorists watch in real time); also, T's pre-existing chronic back pain intensifies during these assaults and the fbi assassins watch and listen as T moans in sleeplessness (from psychotronic attack) and pain (from L-4, L-5 disc injury from service in Viet Nam). The next morning T sees the following e-mail :

Note: Habituation is made more difficult when the fbi reduces for a few days the tamperings, messagings and provocative assaults; this means that T guardedly enjoys a few days of relative peace, but the impact on his psyche upon the renewal of hostilities is damaging.

### September 23, 2002 From Brownsville, Texas

SLEEP DEPRIVATION technique via hi-tech psychotronics ( infrasound, electromagnetic, etc. devices) is effectively used by the fbi thugs and assassins against T on the night of September 22, 2002, from 10:00 PM to 6:00 AM. The following morning the thugs enter T's car and turn on the blower fan to high speed as though to remind T that cooling off is helpful after the previous night's 'heat' treatment to the brain.

### September 28, 2002 From Brownsville, Texas

Psychoelectronic assaults causing sleep deprivation continue all night on September 26, 2002. T is sleepy and on edge the next day. Also, poisonings continue. Home and car invasions regularly occur; today T discovers that the fbi thugs enter the car, open T's briefcase and take apart the ball point pens, leaving the parts of the pens scattered around the case. T also learns this date that Senator Feinstein contacted the fbi regarding the \$10,000 that the fbi illegally took from T in 1978 (this matter is pending). This kind of mischief sends three messages to T: First, that the vitamins that T takes everyday may be "medicated" (poisoned) and secondly that the thugs continue to monitor T in his car and in his living space and that no area of T's life is private; thirdly, the thugs intend to catch T off guard by causing T to discover new tamperings from time to time, especially at a time when T is tired.

T receives announcements of support from several sources.

### September 28, 2002

Barbara- This message is in reply to the following statements sent to you:  
"She is apparently seriously mentally ill, as is her sister Barbara Hartwell. I know nothing about you, but since you seem to be a target of this lunatic Hartwell there must be something good about what you are doing. ...If you would like the documentation for some of this and an account of the incident (Hartwell went to NC and helped her sister after the arrest) just reply to this e-mail. Hartwell has apparently also been sending out death threats in e-mail under hacked e-mail accounts at Yahoo and using the name Dimitry Arbatov. Just a Friend".

### Geral Sosbee writes:

The above quoted statement exemplifies the ignorance and the illness that permeates the law enforcement and the intelligence communities in the United States; when the Target of the fbi/



cia succeeds in bringing world attention to the innumerate and often evil practices of the employees of these two agencies (among others), then government agents, operatives, thugs and supporters show their true colors by their renewed efforts to turn the world against the Target. In the case of Barbara Hartwell the thugs in the fbi/cia once again overestimate their powers of persuasion, as Barbara (the articulate and courageous warrior that she is) holds up for us to see in her reports, even while she is under intense fire, the mirror that reflects the low nature of the fbi and the cia mental dwarfs pursuing her on all sides. If, on the other hand, the above quoted passage were written by one who simply hides his identity for personal reasons, then that author needs to abandon his abode in the dark side of consciousness and to awaken to the joys associated with our work (Barbara's and mine) of making positive and lasting contributions to the improvement of the human condition. The one idea that the coward got right in the above silly message is that, "Hartwell..helped her sister ...." Helping people is Barbara's great calling and talent; we should all be so blessed.

#### September 30,2002, From Brownsville, Texas:

On the evening of September 28, 2002, fbi operative introduces himself to T as a U.S. Treasury agent and states as follows: the recent withdrawal by T of cash from T's checking account was monitored by the fbi and Treasury officials and all moneys were in marked \$100 dollar bills; further, any effort to laundry or spend the marked bills will be used as a basis to arrest T.

T notes that this kind of threat is consistent with other intimidation techniques intended to wear down T's defenses and to further demoralize T. T, however, recognizes that any effort to arrest T on criminal charges may be a blessing in that the fbi will have played out their trump card by then placing T in prison.

T has already announced to the banks via this website that the fbi and the cia terrorist efforts to silence T has led to a financial collapse associated with years of assaults, poisonings, and slander (preventing T from gaining employment).

#### From Brownsville , Texas . October 1, 2002

Increased harassment is noted over the past few days. On September 30, 02, the fbi thugs tamper with T's mail on the same day that the United States Postal Inspector advises T that no evidence suggests tampering with the mail. On the same day, the thugs repeatedly enter T's car to make adjustments on those interior settings that T touched in the moments preceding the thugs entry; on the same day an fbi operative assaults T on a new Honda motorcycle in the parking lot of University of Texas at Brownsville. Additionally, the fbi intensifies harassing phone calls, e-mails and other messaging techniques intended to keep the Target on edge. Poisonings continue, but T attempts to eat only where he can observe the preparation of the food.

These same tactics are the only ones that the assassins know well and rely on because they are taught by their Mental Dwarf Mentors (MDMs) in Washington, D.C., that every human being has a breaking point and that even this target (Sosbee) cannot endure much longer the hardship put upon him around the clock by teams of our finest Mental Dwarfs.

T is unphased by all of this, but is ever saddened to realize that the United States of America is collapsed, as evidenced by the desperate antics of these fbi hi-tech cut-throats whose thought processes are limited to the same old themes of killing, imprisoning and torturing the targets and whose assignments around the world involve the same objectives as those described herein. **From Brownsville, Texas. October 2, 2002:**

fbi assassins-mental dwarfs use the psychotronic sleep deprivation technology on T intermittently on the night, morning of September 30, October 1, 2002. On October 1, 2002, the thugs enter T's car while T is in the bank and the terrorists once again change the settings inside the car; then, as T approaches the car and unlocks the door with his key, the fbi assassins use their remote control unit to lock T's car. This tactic is performed twice on this date (Oct.1). T learns this date that his efforts to obtain Texas vehicle title and registration repeatedly fail because the fbi thugs and criminals steal the required documents that T attempts to submit to the authorities. The same scenario occurred when T recently attempted by mail to open a bank account in San Antonio, Texas. Thus, not only does the fbi steal and otherwise tamper with incoming mail for T, the mental dwarfs also intercept T's outgoing mail (and purloin selected items therefrom) in order to make every aspect of T's life extra laborious and frustrating. Even T is amazed to learn of the bizarre tricks that the mental dwarfs play; often only minimal signs suggest that the little ones are engaged in their sinister and criminal art. The following coincidental events are noted for the record:  
T attempted to relocate from Los Angeles, California to Brownsville, Texas. The fbi thugs, cowards and assassins went into full swing with their terrorist tricks against T. October 6, 2002  
Psychological Operations continue against T:**

On the evening of October 5, 2002, fbi goon squad (death squad) members enter T's quarters and remove the shower head; T leaves the quarters for an hour and upon T's return T discovers that the plumbing fixture in the commode has been broken (during that one hour interval). The tampering with plumbing fixtures is a favorite activity for the death squad (and has been used numerous times in the past four years) because the terrorists want to send a symbolic message to T from time to time. The message is consistent with the themes previously set forth in My Story In Detail.

From Brownsville, Texas  
October 8, 2002

On October 7, 2002, fbi intensifies harassment by repeated invasions into T's sleeping quarters and car and tampering with the effects and settings therein respectively. The terrorists particularly seem to enjoy entering T's car during the one to three minutes intervals when T goes to a restroom, or has a cup of coffee; in some instances the thugs predict where T will have the morning coffee, have a goon squad member in place and perform their treacherous art which on some targets causes extreme neuroses, or worse. T is grateful to the mental dwarfs for affording T the information regarding their MO (mode of operation) in order that T may document same for the benefit of the world. GERALD SOSBEE

October 16, 2002

The program to silence T just goes on and on: During the last few days fbi thugs attempt to provoke T by assaults and by home and car invasions and tamperings. On the evening of October 15, 02, fbi uses sleep deprivation against T all night without interruption and fbi observes T in real time as T packs his things to move the next morning. T is very sleepy and not able to function with his usual keen alertness this date. T also notes that the recent update to My Story regarding the fbi efforts to lure T into an fbi operative's home in the state of Georgia (as a kind of false sanctuary) was not simply coincidence. Such effort was orchestrated by the fbi to try to get T to shut up. The intense terror campaign to cause T to have a breakdown has failed and even fbi operatives' offer to T to give T free rent and safety in Georgia failed. Now, T expects a continuation of the same or worse attacks on him from the mds. On the bright side T is heartened to learn that the site (sosbeevfbi.com) is effective worldwide in shining a light on the fbi's corruption, criminality and gratuitous treachery. Cheerio. GERALD

T considers the possibility that 'Tradeout' (items # 63 & 64 above) is a possible fbi message and T runs a test against the thugs: T sends an e-mail message to BH (a supporter) indicating that the fbi offers to slack off the assaults, provided T stops his campaign to destroy the fbi/cia; T writes to his supporter that he does not negotiate with terrorists and that the offer of a 'Tradeout' is **UNACCEPTABLE**. Then, T (aware that the fbi follows T via the tracking device inside T's person, and T also cognizant that the fbi also lately coordinates the tracking of T's person with a simultaneous tracking of T in relation to his physical proximity to T's car) brings a witness to accompany T to his car (a witness not seen by the fbi punks sitting in a remote location). The fbi, unaware that T is now approaching T's car **with the witness**, locks by remote device the door locks on T's car seconds after T unlocks the door; T's witness (one L S) observes the incident and L S at T's suggestion then reports to a third party (D) at the Texas State Technical College (Harlingen, Texas) the electronic tampering to T's car which L S just witnessed.

T is heartened that once again he has allowed the fbi to stumble on its own electronic wizardry in a game that T is all too happy to play.
